

# BOARD CERTIFICATION PROGRAM OVERVIEW



## American Board of Optometry Board Certification and Maintenance of Certification

American Board of Optometry Board Certification allows doctors of optometry to demonstrate that they exceed entry-level requirements and maintain appropriate knowledge, skills and experience to deliver quality eye care. The program was developed in 2009 to offer optometrists a voluntary pathway to a meaningful Board Certification credential. The Board Certification exam is offered each January and July; upon passing it, Diplomates enroll in a 10-year Maintenance of Certification (MOC) process.

### Earning Board Certification

Optometrists earn Board Certification through a multi-step process beginning with an initial application. Below is a detailed overview of the certification process.

#### • Step 1: Initial Application

- a. OD completes online application and submits nonrefundable \$300 application fee.
- b. OD submits the following documentation:
  - Graduation from school or college of optometry accredited by the Accreditation Council on Optometric Education (ACOE).
  - Active license to practice therapeutic optometry in a state, District of Columbia, U.S. commonwealth or territory.
  - Authorization to search the National Practitioner Data Bank.
- c. OD acknowledges that once Board Certification is earned, it must be kept current through enrollment in the 10-year Maintenance of Certification program.
- d. OD affirms all supplied information is true and correct, and grants the American Board of Optometry permission to verify credentials.



#### • Step 2: Verification and Active Candidate Status

- a. American Board of Optometry verifies all supplied information. This process generally is completed within 30 days after application date.
- b. Once information is verified, applicant is granted Active Candidate status.
- c. Initial Active Candidate status is granted for one year, and may be renewed for up to three years by submitting proof of 50 points toward Post-Graduate Requirements for each year of eligibility.
- d. If any supplied information cannot be verified, candidate is contacted to resolve the issue.

#### • Step 3: Meeting Post-Graduate Requirements

- a. To be eligible for the exam, Active Candidate must attain 150 points under the "residency or equivalent" rule. If points are not attained through an ACOE-accredited residency, Candidate must submit proof of three years of active licensure and clinical practice.

Points are attained through the following activities:

##### **ACOE-accredited residency:**

- 150 points if completed in the past three years
- 100 points if completed in the past three to 10 years
- 50 points if completed more than 10 years ago

##### **Active Clinical Practice:**

- 5 points for each year of practice in the previous 10 years, up to 50 points

### Fellowship in the American Academy of Optometry (FAAO):

- 50 points if completed in the past 10 years
- Status must be active and current

### Fellowship in College of Optometrists in Vision Development (FCOVD):

- 50 points if completed within the past 10 years
- Status must be active and current

### Diplomate of a section of the American Academy of Optometry (AAO):

- 50 points if completed within the past 10 years
- Status must be active and current

### Graduate Degree:

- 50 points if completed within the past 10 years

### Continuing and Other Education:

- Up to 150 points
- Education expires three years from date of completion. Once education has been submitted for verification, it is locked in through the next testing period.
- Education is separated into two categories:
  1. At least 50 percent of education points (up to 150) must come from Category 1, as outlined in the point system overview.
  2. A maximum of 50 percent of education points (up to 75) may come from Category 2, as outlined in the point system overview.

#### • Step 4: Taking the Examination

- a. Upon meeting Post-Graduate Requirements, Active Candidate pays the \$1,500 exam fee and schedules an exam date at a Prometric Testing Center.
- b. The Board Certification exam is a computer-based patient assessment and management test emphasizing clinical knowledge and skills, not didactic details.
- c. Examination is held twice annually in January and July at Prometric Testing Centers worldwide.
- d. Active Candidates must take the examination within 12 months following exam registration. A Candidate who does not take the exam within those 12 months must resubmit Post-Graduate Requirements. Active Candidate status applies for a maximum of four years.
- e. Candidates are notified of exam pass or fail status by mail, within 60 days following the exam. Results cannot be given over the phone or by e-mail.

## Maintenance of Certification (MOC)



Upon the Candidate's successful completion of the Board Certification Examination, the American Board of Optometry confers **Board Certified Diplomate** status for a period of 10 years.

Board Certification **must** be kept current through the 10-year American Board of Optometry Maintenance of Certification process. For 2015, the annual maintenance fee is \$195; it includes an annual Self-Assessment Module or Performance in Practice Module.
